Clyde Township has installed a secure drop box for taxes at the Township Hall 1679 56<sup>th</sup> Street. The Mail slot is located at the rear of the building – labeled “Mail”. Taxes (either money order or checks) may be deposited in the mail slot. A receipt will be mailed.

**Taxes are no longer to be paid at a private residence in Clyde Township.**

**Taxes may be paid in person on appointed days only as noted below:**

**The Township Treasurer will be at the Township Hall (back office) on the following dates and times to collect:**

**July 2014: Saturday, July 26 – 8:30 am until 11:30 am.**

**August 2014: Saturday, August 16 – 8:30 am until 11:30 am.**

**September 2014: 1) Saturday September 13 – 8:30 am until 11:30 am**

**2) Monday, September 15 – 9:00 am until 5:00 pm\* (last day without interest.)**

**\* Closed between 12:00pm and 1:00pm for township business.**

**Please do not to try to pay taxes at the Allegan County Treasurers office. Allegan County cannot accept local township taxes until March 3, 2015.**

**Delinquent Property Tax Notice:** A Delinquent Property Tax Notice is listed on any tax bill turned over to Allegan County on March 1, 2014 as delinquent and has not been paid as of June 1, 2014. The notice is located in the Property Information section of the tax bill. Delinquent tax notices were mailed out by Allegan County in April 2014. This is a reminder there is still a balance due to Allegan County. Local Treasurers cannot collect delinquent taxes, please call Allegan County Treasurer’s Office at (269) 673-0260 for final balance due and payable to “Allegan County Treasurer”.
